SCOPE OF SERVICES

- A. Statement Overview. The Service Provider shall render the Department of Finance Equipment and Maintenance Service for Twelve (12) Months, for the items covered by this TOR.
- B. Services to be provided upon issuance of Notice to Proceed (NTP):

Corrective Maintenance.

- 1. The Service Provider shall immediately attend to service calls/requests of the Department of Finance by providing immediate telephone support to diagnose and remedy the reported incident. For this purpose, the Service Provider shall at all times maintain a 24-hour telephone support service to receive the calls of DOF.
- 2. If the incident cannot be resolved off-site, an on-site engineer shall be deployed immediately to DOF.
- The Service Provider shall supply the necessary spare parts and/or equipment for the purpose of maintaining the working condition/function of Equipment listed in this TOR (see list of equipment).

Preventive Maintenance.

The Service Provider shall perform a routine preventive maintenance activity at the DOF premises, every quarter, for the equipment listed in this TOR

The scope of Preventive Maintenance activity will be the following:

- General check-up of the equipment, hardware and software
- Conduct a comprehensive diagnostic routine within the system.
- In case the equipment is found faulty and the same needs to be pulled out by The Service Provider for Return Material Authorization (RMA) request to Cisco, a replacement unit of the same or alternative equipment specification shall be provided while the faulty equipment is undergoing RMA. The Service Provider shall shoulder all related costs which include shipment of the equipment that is subject to RMA. The Service Provider shall return and re-install the equipment to DOF within Thirty (30) days from date it is pulled-out for RMA. Should the Service Provider fails to return or re-install the equipment within the said period, the service unit provided shall become the property of DOF.
- For any troubleshooting and/or fault-fixing call regarding Software or any system concerns, The Service Provider shall assign an on-site support to do trouble-shooting and fault-fixing. Available software patching for bug-fixes shall be done as necessary. The Service Provider must coordinate with DOF representative until the issue has been resolved. Regular updates of fault rectification shall be provided as necessary.
