# Job order services for printed collaterals for the economic, fiscal, and institutional reforms' public communication and engagement project

#### I. Background

The COVID-19 pandemic has hurt the lives and livelihoods of many Filipinos. As the country continues its fight against this pandemic, the Department of Finance (DOF) lays the groundwork to steer the Philippines back on its course to achieve a high-income country status by 2040. To ease the suffering of the people, the government has been implementing programs to safeguard the public's health and revive the economy. Among the economic, fiscal, and institutional reforms are the remaining packages under the Comprehensive Tax Reform Program (CTRP) that seek to make the tax system simpler, fairer, and more efficient, as well as provide support to businesses and ordinary Filipino citizens who are critically-impacted by the pandemic.

As revealed by the market study by the Strategy, Economics, and Results Group (SERG), print remains to be one of the most effective channels to promote awareness and communicate to the public the economic, fiscal, and institutional reforms, such as the remaining packages of the CTRP and other priority programs of the Duterte administration. These priority reforms and programs consist of the Corporate Recovery and Tax Incentives for Enterprises (CREATE) Act, Real Property Valuation and Assessment Reform Act, Passive Income and Financial Intermediary Taxation Act (PIFITA), Bayanihan to Recover as One Act (Bayanihan II), and the Build Build Build program, among others.

With the different packages covering a broad audience, the communication strategy covers all socioeconomic classes (A, B, C, D, and E), male and females who are at least sixteen (16) years old across the country.

#### II. Scope of work

The supplier shall provide proof of the broadsheet false covers before actual production for the enduser to assess and evaluate the quality and accuracy of printing in case adjustments on the design and layout are needed to match the desired output.

Delivery can be done in batches during the said schedule. The supplier/printer shall coordinate with the requesting office (SERG) to agree on the expected number of copies to be delivered per day on the given schedule of delivery.

#### III. Fund Source and Budget

The budget for this printing services contract is **SEVEN HUNDRED THIRTY-FIVE THOUSAND PESOS (PHP 735,000.00) ONLY**. The budget is based on existing market prices for the procurement of similar services and shall be charged against the Kreditanstalt für Wiederaufbau – Communicating Economic, Fiscal, and Institutional Reforms (KfW-CEFIR) fund.

#### IV. Mode of Procurement

The procurement shall be undertaken through a small value procurement pursuant to DOF and government procurement guidelines.

#### V. Terms of Payment

Full payment shall be given **upon complete delivery** of the broadsheet false covers and shall be subject to the prevailing government accounting and auditing rules, including but not limited to tax obligation/deduction requirements. Deliverables shall be submitted to DOF in both soft and hard copies for payment processing and records purposes.


