**CONTRACT FOR THE LOTS 1, 2 AND 3 OF THE RENTAL OF PRINTERS WITH
TONERS IN THE DEPARTMENT OF FINANCE FOR CY 2021**

THIS AGREEMENT made the ____ day of _____ 2021 between **DEPARTMENT OF FINANCE** of the Philippines (hereinafter called "the Entity") of the one part and **MULTIBIZ INTERNATIONAL CORPORATION** of 470 Lalaan 2nd, Silang, Cavite (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Lots 1, 2 and 3 of the Rental of Printers with Toners in the Department of Finance for CY 2021** and has accepted a Bid by the Supplier for the supply of those goods and services in the amount of **Five Hundred Fifty-Six Thousand Eight Hundred Pesos (P556,800.00)** for **Lot 1** – 32 units Laser Printer, **One Hundred Ninety-Nine Thousand Eight Hundred Pesos (P199,800.00)** for **Lot 2** - 3 units Laser Printer (A3 Paper Size) and **One Million Eight Hundred Eighteen Thousand Pesos (P1,818,000.00)** for **Lot 3** – 10 units Laser Printer (Colored), with the total contract amount of **Two Million Five Hundred Seventy-Four Thousand Six Hundred Pesos (P2,574,600.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

Philippine Bidding Documents (PBDs);

- a. Schedule of Requirements;
- b. Technical Specifications;
- c. General and Special Conditions of Contract; and
- d. Supplemental or Bid Bulletins, if any

Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and

3. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
4. In consideration for the sum of **Two Million Five Hundred Seventy-Four Thousand Six Hundred Pesos (P2,574,600.00)** or such other sums as may be ascertained, **MULTIBIZ INTERNATIONAL CORPORATION** agrees for the

Lots 1, 2 and 3 of the Rental of Printers with Toners in the Department of Finance for CY 2021 in accordance with its Bid.

5. The **DEPARTMENT OF FINANCE** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.



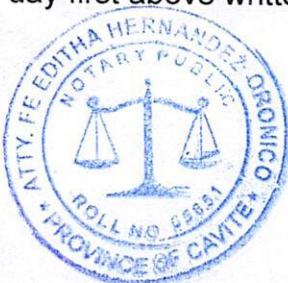
