

**CONTRACT FOR ANNUAL SUBSCRIPTION TO AN ECONOMIC
DATABASE (STATISTA ANNUAL SUBSCRIPTION)**

This CONTRACT executed on the _____ day of _____ 2025 by and between:

DEPARTMENT OF FINANCE, a government agency of the Republic of the Philippines, hereinafter called "the Entity";

-and-

CE-LOGIC, INC. a company duly organized and existing under the laws of Quezon City, Philippines, with principal office at 839 EDSA, South Triangle, Quezon City, hereinafter called "the Supplier".

WHEREAS, the Entity invited Bids for certain goods and services/works/consulting services, particularly **Annual Subscription to an Economic Database (Statista Annual Subscription)**;

WHEREAS, the Supplier submitted a responsive bid and was awarded the contract for the procurement in the total amount of **One Million Forty-Five Thousand Nine Hundred Fifty Four Pesos (Php1,045,954.00) inclusive of all applicable taxes**, hereinafter referred to as the "Contract Price."

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:


1. Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Conditions of Contract, which form an integral part of this Contract.
2. The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009 shall form part and be read and construed as integral parts of this Contract, viz.:
 - a. Request for Quotation
 - b. Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - c. Notice of Award of Contract; and the Bidder's Conforme thereto; and
 - d. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned, such as but not limited to the Notice to Proceed and Warranty Security.
3. In consideration of the Contract Price of **One Million Forty Five Thousand Nine Hundred Fifty Four Pesos (Php1,045,954.00) inclusive off all applicable taxes**, or such other sums as may be determined in accordance with the terms of the Contract, the Supplier agrees to deliver and perform the items and related services for the **Annual Subscription to an Economic Database (Statista Annual Subscription)** described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.
4. The **DEPARTMENT OF FINANCE** agrees to pay the above-mentioned sum to the Supplier in accordance with the schedule and manner provided in the Bidding Documents and its annexes.
5. Any dispute, difference, or claim arising out of or relating to this Contract, including its existence, validity, interpretation, breach, or termination thereof, may be submitted to arbitration or other form of alternative dispute resolution in accordance with the applicable law, such as Republic Act No. 9285 (Alternative Dispute Resolution Act of 2004) or Executive Order No 1008, series 1985 (Construction Industry Arbitration Law).


